Hello ffab,

Thanks for your interest in our products.

Sales Analytics can do what you want, the only thing is we are finishing right now the development of reports by customer groups. We'll release a new version next week including this feature.

About Sale+Tax+Shipping report for products, shipping costs are not handled by product, but by order. On Products reports you get this data (9 parameters):

- Gross income
- Net income
- Taxes
- Discount
- Cost
- Revenue

- Number of orders
- Number of items
- Weight

And then on Order reports (and also with the new release on Customer Group reports), besides, you get the Shipping Cost data (10 parameters).

The flexible timeframing allows you to set the time period to one month, but also to any number of years, months, weeks and/or days that you want.

And you can export data to CSV.

- Sales Analytics only uses a cloud service to validate the subscription and provide the suitable keys for it to work. But all the data processing and display is performed on your Magento installation, and is kept private on your server.

- Your sales data is not tranferred to anyone, not even to our cloud server. Only your subscription keys are sent to validate the installation and provide the suitable keys.

- And yes, your subscription needs to be active for the tool to work at its full capacity.
